

Privacy Statement

At Pixley Lumber Company, we are committed to safeguarding the privacy and security of information that we collect. We respect your concerns about privacy and value our relationship with you. This Privacy Statement describes the types of information we collect and how we may use that information and with whom we may share it. Our Privacy Statement also describes the measures we take to protect the security of that information. We also tell you how you can reach us to update your contact information, remove your name from our mailing lists, or get answers to questions you may have about our privacy practices.

Information We Collect and How We Use It

We may collect non-public personal information about you from the following sources:

- Information we receive from you on applications or other forms;
- Information about your transactions with us, our affiliates, or others;
- Information from references you authorize us to contact (your banks and creditors); and
- Information we receive from consumer and credit reporting agency.

We do this in order to establish accounts or to complete credit card or other transactions on your behalf. This information may include (but is not limited to) names, addresses, social security numbers, credit card numbers, e-mail addresses, and telephone numbers. We do not disclose any nonpublic personal information about our customers or former customers to anyone, except as permitted by law. This information will be used to conduct your business with Pixley Lumber Company, and to effect, administer or enforce a transaction that you request or authorize. It may be shared with our third party business partners only to the extent that they may require certain information in order to fulfill their business obligations to us, or enforce your obligation to us.

How We Protect Personal Information

We restrict access to nonpublic personal information about you to those employees and agents who need to know that information to provide products or services to you. We maintain administrative, technical and physical safeguards to protect against loss, misuse or unauthorized access, disclosure, alteration or destruction of the non-public information you provide to Pixley Lumber Company. We do not sell or otherwise disclose information about our customers except as stated above. We acknowledge that maintaining privacy of information is required in our relationship with our customers. Since we do not disclose your information except as allowed by law, there is no “opt out” requirement or procedure in place.
